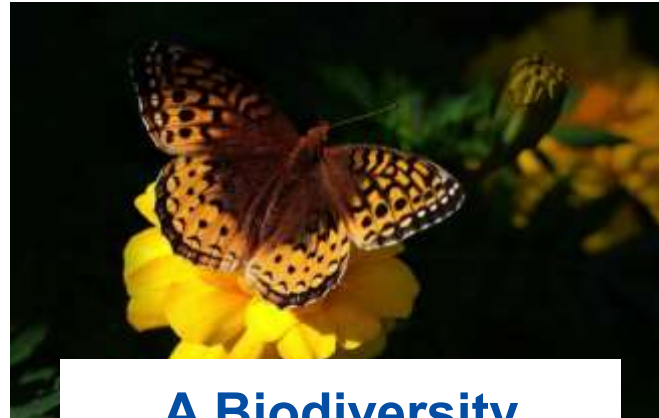

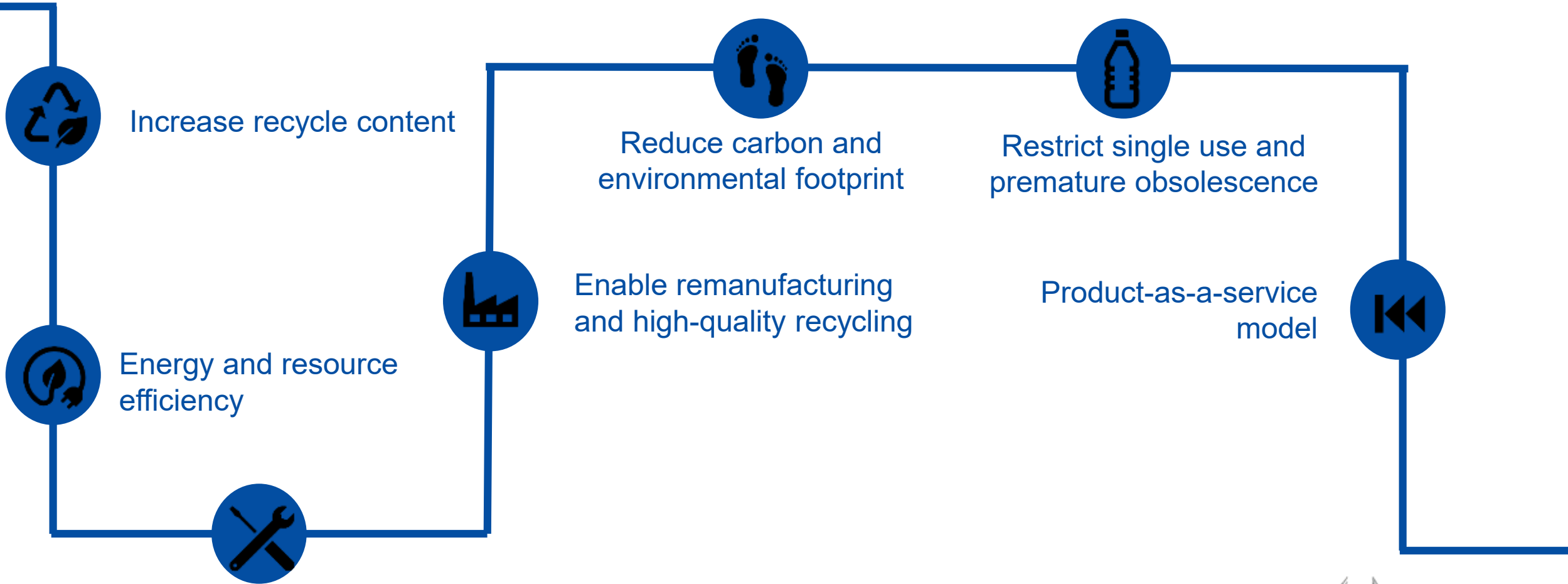




# New CEAP

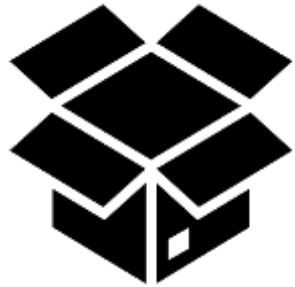

Reducing the risk and use of **pesticides** by 50% by 2030

Halting and reversing the decline of **pollinators**



Increase the quantity, quality and resilience of **forests**

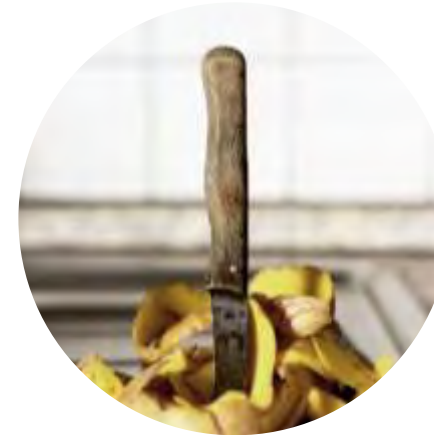

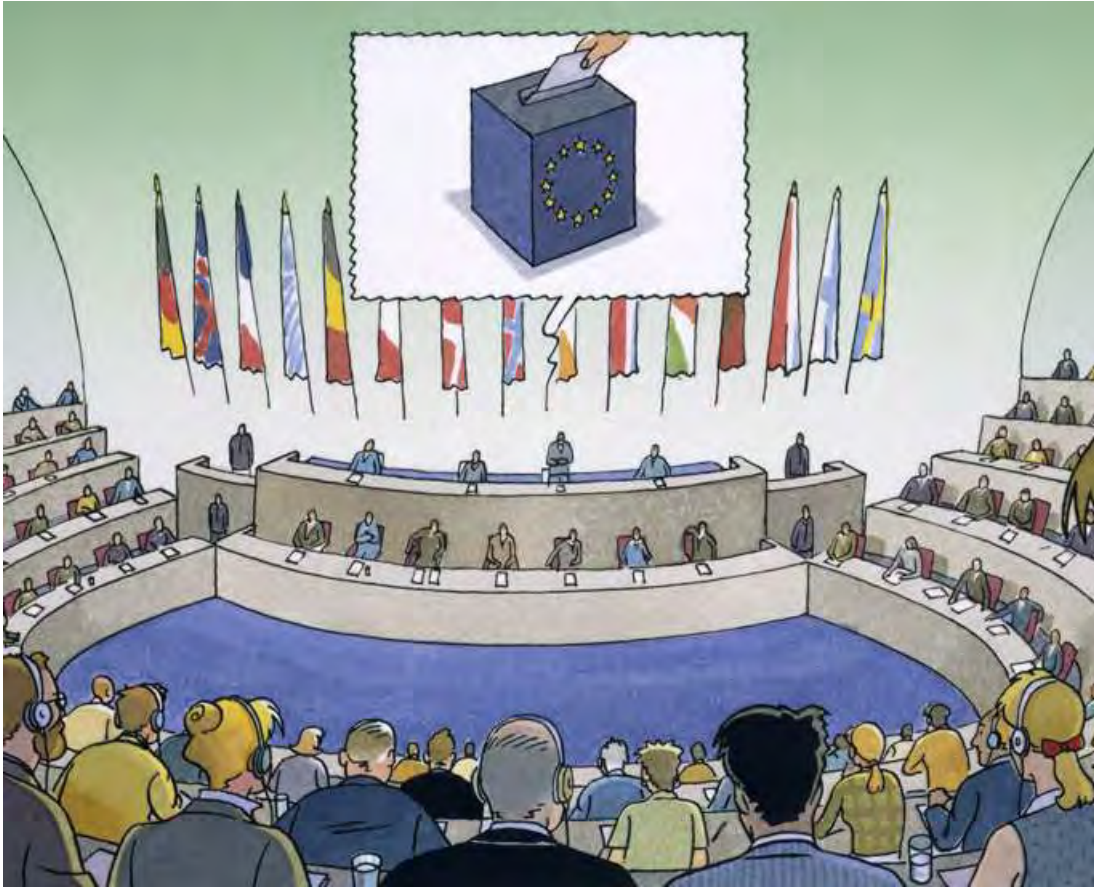
